

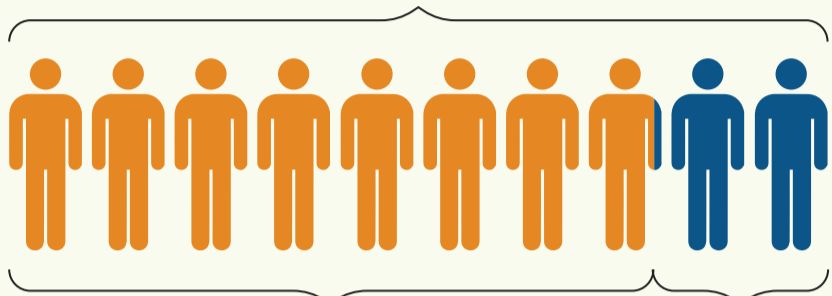

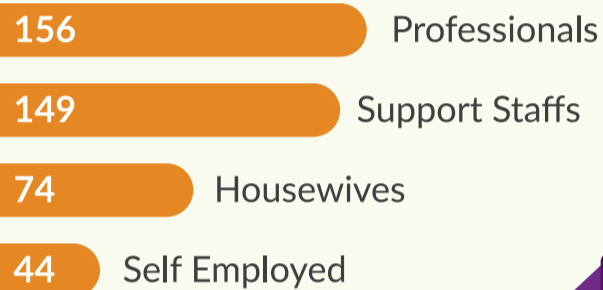

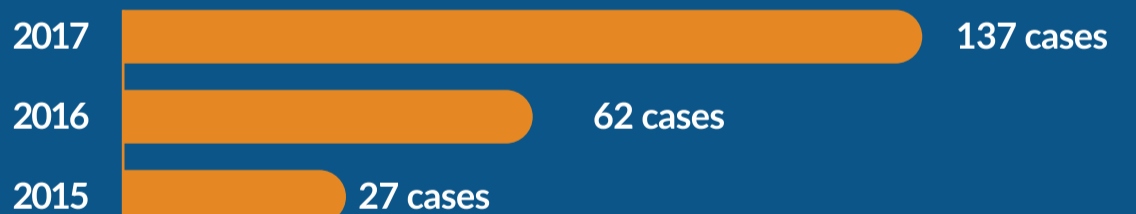

Fasakh application has been recorded as the highest number

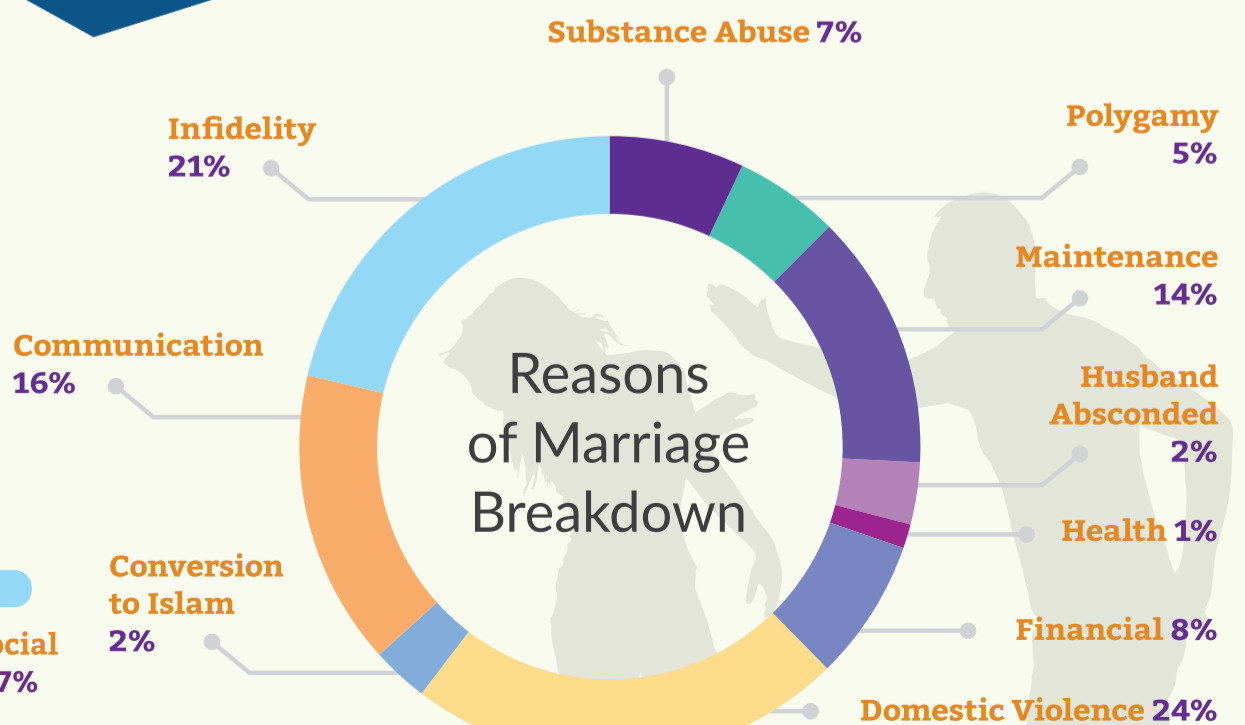
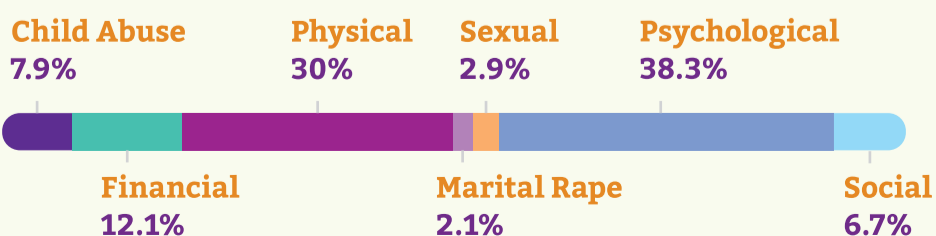


4 DOMESTIC VIOLENCE (DV)

Breakdown of the Types of Domestic Violence



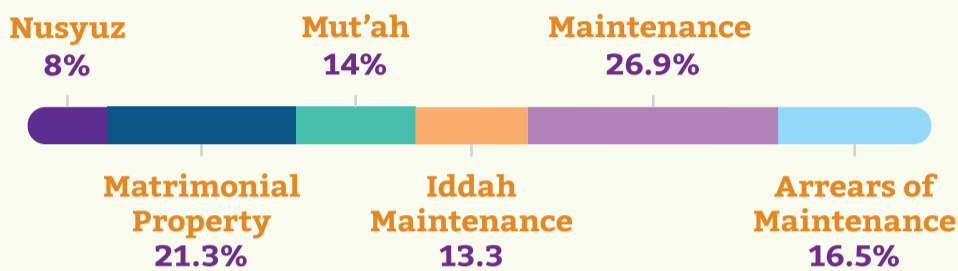

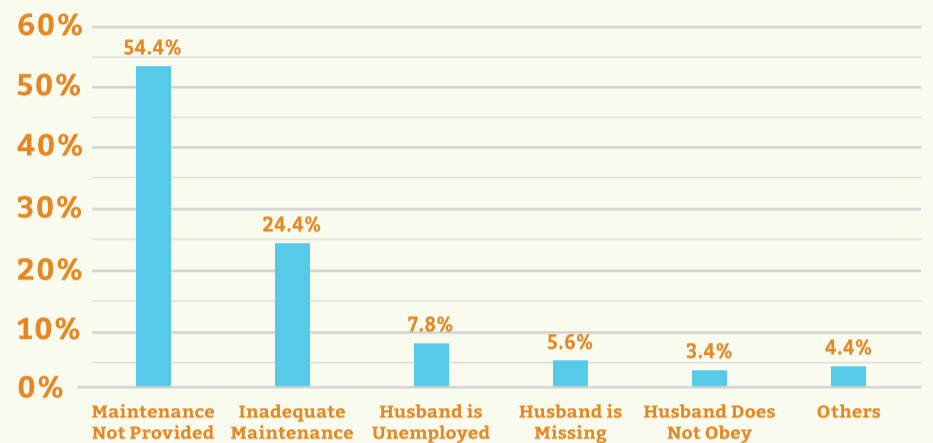
Issues Faced by Wives Due to Divorce

Issues in Wives' Maintenance

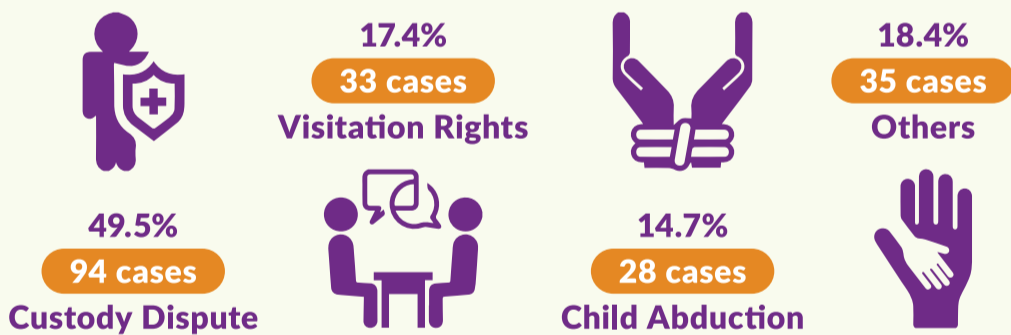


6 CHILDREN'S RIGHTS IN FAMILY

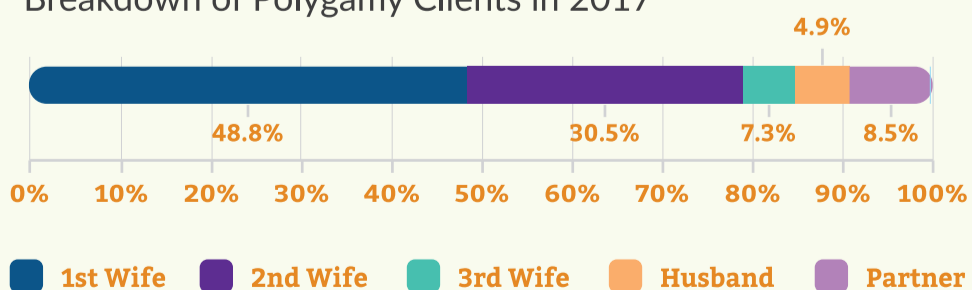


8 POLYGAMY
